Cranbourne East Primary School Student Dress Code

PURPOSE

The purpose of the Student Dress Code is to outline Cranbourne East Primary School requirements for student dress and appearance and to provide information about uniform purchase and support, dress code implementation and exemption processes.

This dress code has been developed by Cranbourne East Primary School's School Council in close consultation with our school community to ensure that it respects the rights of individual students whilst reflecting the values and interests of our community.

The Student Dress Code aims to:

- promote a sense of community and belonging and encouraging pride the school.
- allow all students to feel equal.
- prevent bullying and competition on the basis of clothing.
- enhance the profile and identity of the school and its students within the wider community.

The School Council has developed a dress code that we believe provides a range of choices for students and is cost effective for families.

SCOPE

Students are expected to comply with this Student Dress Code while traveling to and from school, during school hours and when attending school activities.

UNIFORM AND APPEARANCE

Cranbourne East Primary School's compulsory school uniform items are as follows:

- Navy School hat (bucket or slouch style) – MUST be worn in Terms 1 and 4
- CEPS Summer Dress OR navy skort/navy shorts with CEPS polo shirt (long or short sleeve)
- Navy pants with CEPS polo (classic, cargo or trackpants)
- Crew Neck Windcheater, Zip Jacket – 3 stripe rib, CEPS Soft Shell Polyester Jacket – Unisex
- Runners

Cranbourne East Primary School's optional uniform items are as follows:

- Tunic with navy tights and CEPS polo
- Raincoat
- Hijab
- CEPS school bag

General appearance

While at school, travelling to or from school or participating in school activities, Cranbourne East Primary School students must comply with the following:

- Uniforms must be clean and in good repair
- Uniforms should be clearly marked with the owner's name
- Additional layers of clothing may be worn underneath the uniform for added warmth, provided these undergarments are completely hidden

General appearance

Stud earrings and sleepers worn in the ears, and watches are accepted. For safety reasons, students are not permitted to wear necklaces, unless tucked underneath clothing.

Cosmetics may not be worn at school.

Health and safety

Students with shoulder length or longer hair are encouraged to tie back their hair to help restrict the potential spread of nits and headlice.

School uniform hats must be worn outside through Terms 1 and 4. Students are encouraged to wear a school uniform hat outside whenever UV levels read 3 or higher, in Victoria UV levels are typically 3 and above from mid-August to the end of April.

Hats are not to be worn inside.

Students are permitted to wear sunglasses during outdoor activities. Sunglasses should be close-fitting, wrap-around that meet the Australian Standards 1067 and cover as much of the eye area as possible.

PURCHASE OF UNIFORMS

The school uniform is available for purchase from Primary School Wear (PSW).

IMPLEMENTATION

Cranbourne East Primary School will ensure that this Student Dress Code and uniform item list is communicated to all families and students through our website and enrolment packs. We will assist students who may be experiencing difficulties complying with this policy where possible.

If a student is out of school uniform or otherwise breaches the Student Dress Code on a recurring basis, a note will be provided to the student and parents by the classroom teacher. If non-compliance with the student dress code becomes a continued occurrence, the principal will be informed, and a phone call home

may be required. In this event, the school will continue to work with the student and family to support compliance.

EXEMPTIONS TO STUDENT DRESS CODE

We acknowledge that the enforcement of this Student Dress Code may impact students differently.

Students and their parents or carers may apply either in writing or in person to the principal for an exemption to this Student Dress Code if:

- an aspect of this code prevents the student from complying with a requirement of their religious, ethnic or cultural beliefs or background
- the student has a particular disability or health condition that requires a departure from the dress code
- the student or their parents/carers can demonstrate particular economic hardship that prevents them from complying with the dress code.

When the principal receives a request for an exemption, they will:

- consider the grounds for the exemption request
- explain the process to the student and/or their parents/carers
- guarantee that issues of a personal nature revealed to substantiate the request will be strictly confidential
- encourage the student and/or their parents/carers to support their application with evidence.

The principal or delegate will then try to negotiate a resolution that is acceptable to all parties, including providing advice about support with meeting uniform costs. If an exemption is not allowed, then written reasons will be provided to the student and/or their parents or carers.
